Registration/veterinary control: 7.00 - 8.30

Race start: 9.00

Track length: 700 - 1000 m

Track type/surface: Maintained natural terrain, grass, bushes

Technique of pulling the lure: motor reel, pulleys

Beware: Dogs are distinguished exclusively by white, red and blue coats. Each dog

owner is required to provide his own coats.

Participation conditions: Each dog participating in the race must have a valid racing/coursing license.

Muzzles are required for all breeds, except for PLI. In case there are less than

6 dogs on the start from each sex, males and females run together.

Protest: It is possible to submit a protest after paying a 100 EUR deposit, which, when

illegitimate, forfeits in favor of the organizer. In case the protest is legitimate, the deposit will be returned to the submitter. The protest will be assessed by the judges committee and the head of the race. It is not possible to submit a

protest against judges' decisions.

Veterinary conditions: Each dog owned by a Slovak citizen must have a veterinary card with valid

vaccinations according to Slovak law. Dogs from abroad must have a PET PASSPORT with a valid vaccination against rabies. Veterinary confirms in the pet passport or in an accompanying document that the dog shows no clinical signs of disease and is able to withstand carriage to its destination at the time of issuing the confirmation. Dogs older than 6 years and younger than 2 years must attend a second veterinary control which will take place after the first

round.

Neither the organizer, nor the officials are responsible for injuries incurred by the dog owners, the dogs or the officials. Likewise, they accept no responsibility in case of escaped dogs.
